Person Studied in Tamil medium means a person who has studied through Tamil medium of instruction upto the educational qualification prescribed for direct recruitment in the rules or regulations or orders applicable to any appointment in the services under the State. The provisions of Persons Studied in Tamil Medium (PSTM) Act 2010 as amended in Persons Studied in Tamil Medium (Amendment and Validation) Act, 2026 (Act No.12 of 2026) are applicable for Notification No. 7/2026 dated 11.08.2026.
