Subject: Advertisement Notice for Direct Recruitment to the Post of Constable (Level-02), General Cadre (Executive, Armed/IRP, SDRF, Women and Border Battalions) in Ladakh Police – 2026.

Online applications are invited from eligible candidates for direct recruitment to the post of **Constable (Level-02), General Cadre (Executive, Armed/IRP, SDRF, Women and Border Battalions) in Ladakh Police**, against **331 vacancies**, in accordance with the Ladakh Police (Subordinate) Service Recruitment (Revised) Rules, 2026, the applicable reservation rules/orders, the Standing Order governing direct recruitment to the post of Constable (Level-02), and other applicable orders/instructions issued by the Administration from time to time.

Link for Submission of Online Application:

Eligible candidates are required to fill out the online application form by visiting the official website of Ladakh Police at the designated link, viz., <https://police.ladakh.gov.in>. The date of activation of this link for submission of online application form shall be **29.08.2026**, and the last date for submission of the online application shall be **15.09.2026**. Candidates may edit their particulars in the online application form after the initial submission until the last date for submission by logging in with their registered mobile number. **However, the Date of Birth and Category fields in the application form cannot be edited after submission.** Moreover, some fields may not be editable once submitted. Candidates are therefore advised to fill in the form carefully and verify all details before submission. Candidates are advised to visit the official Ladakh Police website regularly for updates.

Candidates applying for vacancies in the Women Battalion and Border Battalion shall be eligible to apply only against the vacancy/vacancies pertaining to their domicile district, as determined by the competent authority. A candidate shall not be permitted to seek appointment against vacancies of more than one district.

4. RESERVATION

The vacancies shall be filled in accordance with the applicable provisions of the **UT of Ladakh Reservation (Amendment) Rules, 2025**, S.O. 77 dated 27.06.2025, the operative/post-based roster and other applicable orders/instructions of the Administration.

The vertical reservation shall be as follows:

Category	Percentage of available vacancies
Unreserved (UR)	5%
Scheduled Caste (SC)	1%
Scheduled Tribe (ST)	80%
Residents of areas adjoining Actual Line of Control (ALC)	4%
Economically Weaker Sections (EWS)	10%
Total	100%

The category-wise distribution of the 331 posts shall be strictly as per the **approved operative/post-based roster**, which shall form part of this advertisement as **Annexure-I**.

Candidates seeking reservation benefits shall possess the requisite category certificate issued by the competent authority in the prescribed format **on or before the last date of submission of online application forms**, unless otherwise specifically provided under the applicable rules/orders.

5. HORIZONTAL RESERVATION / SPECIAL CATEGORIES

In addition to the above vertical reservation, the following horizontal reservations shall be applicable, subject to the applicable rules/orders:

1. **15% for serving Special Police Officers (SPOs)** of Ladakh Police who fulfil the prescribed educational, physical and medical standards and have completed at least three years of continuous engagement on the last date of submission of applications.
2. **4% for Voluntary Home Guards (VHG)**s of Ladakh Police who fulfil the prescribed educational, physical and medical standards and have completed at least five years of continuous engagement on the last date of submission of applications.
3. **4% for Outstanding Sportspersons (OSP)** who fulfil the prescribed educational, physical and medical standards.
4. **20% for Ex-Agniveers** who fulfil the prescribed educational, physical and medical standards.
5. **6% for Ex-Servicemen**, in accordance with the applicable rules/orders.

Where suitable candidates are not available against the respective horizontal reservation, the vacancies shall be dealt with in accordance with the applicable Recruitment Rules/Standing Order and shall not be carried forward, wherever so prescribed.

Special provision regarding Outstanding Sportspersons (OSP)

- (i) 4% of the advertised vacancies shall be reserved horizontally for Outstanding Sportspersons (OSP) in accordance with the Union Territory of Ladakh Outstanding Sportspersons (Horizontal Reservation in Direct Recruitment to Group 'C' Posts) Rules, 2026, notified vide S.O. 247 dated 18.08.2026, and the applicable instructions of the Department of Personnel and Training (DoPT), Government of India.
- (ii) OSP reservation shall operate as horizontal, interlocking reservation across the applicable vertical reservation categories. A candidate selected against OSP reservation shall be adjusted against the vertical reservation category to which the candidate belongs.
- (iii) For the purpose of this recruitment, an 'Outstanding Sportsperson' shall mean a sportsperson eligible for recruitment in accordance with the eligibility criteria, recognized competitions, recognized sports disciplines, order of preference and other conditions prescribed under the aforesaid Rules and the applicable DoPT instructions, as amended from time to time.
- (iv) Only achievements in recognized competitions and recognized sports disciplines, supported by certificates issued by the competent authority in the prescribed form, shall be considered. The sporting achievement must have been attained on or before the last date prescribed for submission of online applications, i.e. 11.09.2026.



- (v) Candidates claiming OSP reservation shall indicate the claim in the online application and shall furnish/upload the prescribed sports certificate(s) and supporting documents in the manner specified by the Board. Where the recruitment portal does not permit complete submission of the prescribed sports documents at the initial stage, the Board may prescribe a separate OSP document-submission/scrutiny window before preparation of the Sports Merit List.
- (vi) The competent authorities for issuance of sports eligibility certificates and the prescribed forms shall be those specified under the applicable DoPT instructions. No certificate other than a certificate issued by the competent authority in the prescribed form shall be accepted for determining eligibility under OSP reservation.
- (vii) The Department of Youth Services and Sports, UT Ladakh, shall constitute a three-member Committee of its officers for assisting the recruiting agency in examination and verification of the certificates and sporting achievements submitted by candidates. The recommendations of the Committee shall be taken into consideration by the recruiting agency/appointing authority while determining OSP eligibility.

A separate Sports Merit List of candidates found eligible for OSP reservation shall be prepared on the basis of sporting achievements, in accordance with the order of preference and scoring matrix prescribed under the OSP Rules, 2026. Sports Merit shall be assessed on the following scoring matrix:

- (i) Selection under OSP reservation shall be subject to verification of eligibility and genuineness of certificates by the competent authority/recruiting agency. Furnishing false, fabricated or invalid sports information/certificates shall render the candidature or appointment liable to cancellation and may invite action under law.
- (ii) Where an eligible OSP candidate is selected otherwise than against the OSP reservation, such candidate shall not be adjusted against the OSP-reserved vacancy; the next eligible candidate in the Sports Merit List shall be considered against the OSP vacancy. If no eligible OSP candidate is available to fill the prescribed reservation, the vacancy shall be filled in accordance with the normal procedure prescribed for direct recruitment, as applicable.
- (iii) In case of a tie in the Sports Merit List, preference shall be determined successively by: (a) higher level of competition; (b) higher medal/position; (c) Senior level over Junior level; (d) higher marks in the recruitment process, wherever applicable; and (e) older candidate.
- (iv) Where a candidate has participated in both Senior and Junior National Championships/Games, the achievement at the Senior level shall rank higher, in accordance with the OSP Rules, 2026.
- (v) Where a candidate possesses more than one sporting achievement, only the highest achievement shall be taken into account for determining inter se merit. No additional preference or weightage shall be granted merely for winning more than one medal or securing more than one position.

Order of preference and points for the Sports Merit List shall be as follows:

6. DOMICILE

- (i) A candidate applying for the advertised post must possess a valid **Domicile Certificate of the Union Territory of Ladakh**, issued by the competent authority in accordance with the applicable rules.
- (ii) For the purpose of preference and allocation to the Border Battalion, the candidate must possess a valid Domicile Certificate establishing domicile in an eligible border village, as recognized by the competent authority.

7. ESSENTIAL EDUCATIONAL QUALIFICATION

- (i) The candidate must have passed **10th Class/Matriculation from a recognised Board of School Education**.
- (ii) However, serving Special Police Officers (SPOs) of Ladakh Police who have completed at least three years of continuous engagement on the last date of submission of applications shall be eligible with **8th pass qualification**, subject to fulfilment of all other prescribed conditions.
- (iii) The prescribed educational qualification must have been acquired on or before the last date fixed for submission of online application forms.
- (iv) Candidates whose qualifying examination result has been declared on or before the cut-off date and who are declared passed may also be considered, subject to production of documentary evidence.



8. AGE LIMIT

The age limit shall be **18 to 28 years**, reckoned as on **01.01.2026**, subject to the permissible age relaxations under the applicable recruitment rules/orders.

The following relaxations shall apply:

Category	Permissible relaxation
SC/ST/ALC	5 years
Ex-Servicemen	As prescribed under applicable DoPT/Administration rules
Serving SPOs with minimum 3 years continuous engagement	Upper age limit of 37 years
Serving VHGs with minimum 5 years continuous engagement	Upper age limit of 37 years

For Ex-Servicemen, the period of actual military service shall be deducted from the actual age for determining eligibility, subject to the applicable rules.

The date of birth recorded in the Matriculation Certificate shall be accepted for determining age eligibility.

9. DESIRED QUALIFICATIONS

The following shall be treated as desired qualifications for award of incentive marks, subject to the applicable rules:

- Proficiency in driving and possession of a valid **Light Motor Vehicle Driving Licence with transport endorsement**; or
- One-year Certificate Course in Computer Application from an institution recognised by **AICTE**, with documentary proof of recognition.

A candidate may claim incentive marks for **only one** of the above desired qualifications.

The desired qualification test shall carry incentive marks up to **5% of the maximum marks of the written examination**.

For candidates claiming driving proficiency, a driving test shall be conducted in accordance with the latest applicable driving-test guidelines of the competent department.

10. INCENTIVE FOR NCC CERTIFICATE HOLDERS

Candidates possessing valid NCC certificates shall be eligible for incentive marks as follows:

NCC Certificate	Incentive
NCC "C" Certificate	5% of maximum marks
NCC "B" Certificate	3% of maximum marks
NCC "A" Certificate	2% of maximum marks

The prescribed certificate must have been acquired on or before the last date of submission of online application forms.



11. MODE OF RECRUITMENT

The selection process shall consist of the following stages in the order indicated:

The general select list shall be prepared on the basis of marks obtained in the Written Examination together with applicable incentive marks for NCC and the Desired Qualification, subject to the applicable reservation provisions. Selection against the OSP horizontal reservation shall be made separately from the Sports Merit List prepared under the OSP Rules, 2026, after the candidate has qualified the prescribed recruitment stages and subject to verification of eligibility.

12. PHYSICAL STANDARD TEST (PST)

The physical standards shall be as prescribed under Schedule-II of the Ladakh Police (Subordinate) Service Recruitment (Revised) Rules, 2026 and the applicable Standing Order.

Male Candidates

- Height: **162 cm minimum**
- Chest: **81 cm unexpanded minimum**
- Chest: **85 cm expanded minimum**

Female Candidates

- Height: **152 cm minimum**

In case of an appeal against physical measurement, the Chairman of the Board may permit re-measurement in accordance with the Standing Order. The result of the re-measurement shall be final.

Note:

In addition to the Admit Card, candidates appearing for the Physical Standard Test (PST) must also bring two recent passport-size colour photographs (*the photograph should be the same as uploaded during submission of the online application form*) and one original ID proof. Acceptable Photo-ID proofs include:

- Aadhaar card/printout of e-Aadhaar,
- Voter ID card,
- Driving License,
- PAN Card,
- Passport,
- College/University ID Card,
- Employer's ID Card (Govt./PSU/Private), etc.

Candidates who do not qualify the Physical Standard Test shall be disqualified and shall not be permitted to participate in further recruitment process.

13. PHYSICAL ENDURANCE TEST (PET)

Only candidates qualifying the PST shall be permitted to appear in the PET.

Male Candidates

1. Long Race – **1600 metres in 7 minutes 30 seconds**
2. Long Jump – **12 feet**, three attempts
3. Push-ups – **20 (one cycle of up and down to be counted as one)**

Female Candidates

1. Long Race – **1200 metres in 7 minutes 30 seconds**
2. Long Jump – **9 feet**, three attempts
3. Shot Put – **4 kg, 14.5 feet**, three attempts

Note:

- i. Candidates must qualify all the above tests separately.
- ii. To qualify the long race, candidates must complete the distance within the stipulated time frame as given above.
- iii. Only those candidates who qualify the long race shall be eligible to attempt the long jump, followed by push-ups for male candidates and shot put for female candidates.
- iv. The PST and PET are of qualifying nature only.

No candidate shall ordinarily be permitted to re-take a PET event after disqualification. Any permissible appeal shall be dealt with strictly in accordance with the Standing Order and the electronic/video/Rfid record of the test.

14. COMMENCEMENT OF PST/PET

The PST/PET process shall commence from **22.09.2026** onwards.

The detailed schedule, batch-wise allocation, venue and reporting time shall be communicated through Admit Cards and/or separate notices published on the official website of Ladakh Police.

15. TRANSPARENT RECRUITMENT PROCESS

The recruitment shall be conducted under the **Transparent Recruitment Process (TRP)** of Ladakh Police.

The Board may employ technology including:

- RFID/electronic timing for long races;
- electronic distance measurement/fall detection for long jump;



- biometric authentication;
- CCTV/video recording at recruitment stages;
- other technological measures considered necessary for maintaining transparency, integrity and an audit trail.

The entire PST/PET process shall be appropriately video recorded.

16. DOCUMENT SCRUTINY

Candidates qualifying the PET shall be required to produce original documents along with self-attested copies, including, wherever applicable:

1. Matriculation/10th certificate;
2. Domicile Certificate;
3. Category Certificate;
4. District Domicile/other prescribed certificate for Women/Border Battalion vacancies;
5. Educational qualification certificate;
6. SPO/VHG engagement certificate;
7. Ex-Servicemen Discharge Certificate;
8. Ex-Agniveer certificate/documents;
9. NCC certificate;
10. Driving Licence;
11. Computer Application Certificate and proof of AICTE recognition;
12. OSP certificate/documents, where applicable and as prescribed by the competent authority; and
13. any other document required under the applicable rules/orders.

The scrutiny shall be provisional and all certificates shall be subject to verification from the issuing authority.

17. WRITTEN EXAMINATION

All candidates who qualify PST/PET and whose documents are found in order shall be eligible for the written examination.

The written examination shall be:

- Objective/MCQ type;
- **100 questions;**
- **100 marks;**
- one mark for each question;
- duration: **80 minutes;**
- The question paper shall be bilingual in English and Hindi;
- **no negative marking;** and
- of approximately **Matriculation level.**

18. INDICATIVE SYLLABUS

General Knowledge: Current national and international affairs, India – History, Freedom Movement, Art & Culture, Geography, Economics, General Polity and Constitution, Awards and Honours, Sports, Gender and Weaker Sections, Environmental Issues, Common Abbreviations, Current Technological Developments, and Ladakh – History, Art, Culture, Geography and Current Affairs.

Reasoning: Analogies, similarities and differences, spatial visualisation, spatial orientation, problem solving, analysis, judgment, decision making, visual memory, coding-decoding, non-verbal series, number series, alphabet series and number ranking.

General Science: Basic principles of General Science and Life Science up to 10th Class level.

Arithmetic Abilities: Number System, Simple Interest, Average, Ratio and Proportion, Percentage, Profit and Loss, Time and Work, Work and Wages, Time and Distance, Clocks and Calendars, Mensuration, LCM/HCF, Simple Equations, Square Roots, Bar/Graphs and Data Interpretation.

19. DECLARATION OF RESULT AND MERIT

(i) The list of provisionally selected candidates shall be prepared category-wise against the advertised vacancies on the basis of cumulative merit in the Written Examination and applicable incentive marks for Desired Qualification and NCC certificates, after applying the applicable vertical and horizontal reservation provisions. Selection against the 4% OSP reservation shall, however, be made strictly on the basis of the separate Sports Merit List prepared in accordance with the OSP Rules, 2026.

(ii) The Board shall prepare the select list strictly in accordance with the Ladakh Police (Subordinate) Service Recruitment (Revised) Rules, 2026, the applicable reservation rules/orders, the Standing Order governing direct recruitment to Constable (Level-02), the approved roster, the OSP Rules, 2026, and this Advertisement Notification. Allocation of selected candidates to the respective cadre/unit shall thereafter be made on the basis of merit, applicable reservation, eligibility, availability of vacancies and the preference exercised by the candidate in the online application form

(iii) A waiting list may also be prepared in accordance with the applicable Standing Order.

20. TIE CASES

In case of a tie in aggregate marks, the following principles shall be applied successively:

- Date of birth, with the older candidate placed higher in merit; and
- Alphabetical order of names.

21. MEDICAL EXAMINATION AND CHARACTER VERIFICATION

After declaration of the provisional selection list, the selected candidates shall undergo:

- Medical examination by the prescribed Medical Board;
- Verification of character and antecedents; and



iii. Verification of educational, category, domicile, driving licence, OSP and other certificates from the concerned issuing authorities.

No appointment shall be made unless the candidate is found medically fit and his/her character and antecedents and certificates are verified satisfactorily.

22. PROVISIONAL NATURE OF APPOINTMENT

(i) Any appointment shall be provisional and subject to verification of the genuineness of all certificates/documents furnished by the candidate.

(ii) If any certificate is found to be false, forged or otherwise invalid, the appointment shall be liable to cancellation ab initio and appropriate legal action may also be initiated.

23. IN-SERVICE CANDIDATES

(i) Candidates already serving in Government service shall submit a **No Objection Certificate (NOC) from the concerned Head of Department along with the application**, as prescribed.

(ii) Failure to furnish the required NOC shall render the candidature liable to rejection.

24. LIABILITY TO SERVE

A person appointed to the service shall be liable to serve **anywhere in the Union Territory of Ladakh**, or at such other place as may be specified by the Administration.

25. TRAINING EXPENSES

A person appointed to the service who resigns within the prescribed period shall be liable to refund training expenses/pay and allowances as prescribed under the applicable rules/orders.

26. MISCONDUCT/MALPRACTICE

(i) If a candidate is found indulging in impersonation, concealment of facts, submission of false documents, malpractice, misconduct or any other irregularity at any stage of the recruitment process, his/her candidature shall be cancelled and the candidate may be debarred from future examinations conducted by the Board for such period as may be decided under the applicable rules.

(ii) Appropriate criminal/legal action may also be initiated wherever warranted.

27. ADMIT CARD

Candidates shall download their Admit Cards from the official website of Ladakh Police and shall carry the Admit Card, requisite photographs and prescribed original photo-ID proof at the time of PST/PET and other examinations. In addition to the Admit Card, candidates appearing for the Physical Standard Test (PST) must also bring two recent passport-size colour photographs (*the photograph should be the same as uploaded during submission of the online application form*) and one original ID proof. Acceptable Photo-ID proofs include:

- Aadhaar card/printout of e-Aadhaar,
- Voter ID card,
- Driving License,
- PAN Card,
- Passport,
- College/University ID Card,
- Employer's ID Card (Govt./PSU/Private), etc.



28. EXAMINATION CENTRES

- (i) The recruitment process shall be conducted at **Leh and Kargil** centres.
- (ii) Candidates shall be required to indicate their preferred centre in the online application form. Once the examination centre is allotted/selected, change of centre shall ordinarily not be permitted after closure of the application process.

29. APPLICATION PROCESS

- (i) Eligible candidates shall submit their applications online through the designated recruitment portal of Ladakh Police.
- (ii) Candidates shall ensure that all particulars entered in the application form, particularly name, date of birth, category, domicile and other eligibility particulars, are correct.
- (iii) The candidate shall be responsible for the correctness of all information furnished.
- (iv) After submission, the candidate should retain a printout/PDF copy of the application form for future reference.

30. PREFERENCE FOR CADRE/UNIT

Candidates shall exercise, in the online application form, their order of preference for allocation against the following cadre/unit groups, subject to their eligibility and availability of vacancies:

1. Executive / Armed / IRP / SDRF;
 2. Border Battalion; and
 3. Women Battalion.
- (i) No separate preference shall be permitted or required within the group comprising Executive / Armed / IRP / SDRF. These shall be treated as one preference group and candidates shall not be required or permitted to indicate any inter se preference amongst Executive, Armed, IRP and SDRF.
 - (ii) Only female candidates shall be eligible for consideration against vacancies in the Women Battalion. Male candidates shall neither be permitted to exercise preference for nor be considered against vacancies in the Women Battalion.
 - (iii) Only candidates possessing a valid Domicile Certificate establishing domicile in an eligible border village, as recognized by the competent authority, shall be eligible to exercise preference for and be considered against vacancies in the Border Battalion.
 - (iv) A candidate shall exercise preference only for such cadre/unit group for which he/she is eligible under the applicable rules and this Advertisement Notification. Where a candidate is eligible for only one or two of the aforesaid preference groups, the candidate shall exercise preference only amongst such eligible groups.
 - (v) The preference exercised by a candidate shall be taken into account for allocation against available vacancies, subject to the candidate's merit, applicable reservation provisions, eligibility, district-wise eligibility wherever applicable, and the vacancy position. Mere exercise of preference shall not confer any right to appointment against the preferred cadre/unit.
 - (vi) Allocation to the respective cadre/unit shall be made in accordance with merit, applicable reservation, eligibility, availability of vacancies and the preference exercised by the candidate.
 - (vii) The preference once submitted shall be treated as final and shall not ordinarily be permitted to be altered after closure of the online application process.



31. APPLICATION FEE

- i) **Fee Payable:** ₹600/- (Rupees Six Hundred) only for candidates belonging to the Unreserved/EWS Category. For candidates belonging to SC, ST, and ALC categories, the fee payable shall be ₹500/- (Rupees Five Hundred) only.
- ii) **Mode of Payment:** The fee can be paid only online via Net Banking, Credit/Debit Cards, or UPI on the Recruitment Application Software (RAS) when submitting the online application form.
- iii) **Non-Payment of Fee:** Applications received without the prescribed fee shall not be considered valid and will be summarily rejected. No representation against such rejections shall be entertained. The fee once paid shall not be refunded under any circumstances, nor shall it be adjusted against any other examination or selection for any reason whatsoever.
- iv) **Refund of Excess Payment:** All disputes related to the refund of excess payment, if any, shall be governed by the Ladakh Police (Subordinate) Service Recruitment (Revised) Rules, 2026. Candidates are advised to apply for a refund of excess payment, if any, to the Board with documentary evidence.

32. TRANSPARENCY AND RECORDING OF RECRUITMENT

- (i) The Ladakh Police Subordinate Service Recruitment Board shall endeavour to maintain a fair, impartial, transparent, objective, technology-enabled and tamper-resistant recruitment process.

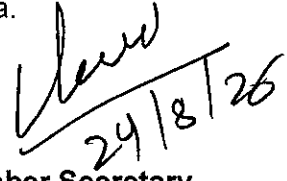
