EDUCATIONAL QUALIFICATIONS FOR THE POST ADVERTISED

DIRECTOR, PHYSICAL EDUCATION: (Pay Level - 10 in terms of 7th CPC)

1. A Master's Degree in Physical Education and Sports or Physical Education or Sports Science with 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
2. Record of having represented the University/ College at the inter-university/ inter- collegiate competitions or the State and/or national championship.
3. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR. (exemption from NET shall be granted in accordance with clause (ii) & (iii) of General Note
4. Passed the physical Fitness Test in accordance with the provisions laid down hereunder

Or

An Asian Game or Commonwealth Games medal winner who has a degree at least at Post-Graduation level.

Physical Fitness Test Norms

- a) Subject to the provisions of these regulations, all candidates who are required to undertake the physical fitness test shall be required to produce a medical certificate certifying that he/she is medically fit before undertaking such tests.
- b) On production of such certificate mentioned in sub-clause (a) above, the candidate would be required to undertake the physical fitness test in accordance with the following norms:

GENERAL NOTE:

- I. The direct recruitment to the post of Director Physical Education (DPE) in the college shall be on the basis of procedure laid down by University of Delhi.
- II. The National Eligibility Test (NET) shall be minimum eligibility for the appointment of DPE.

Provided that candidates who have been awarded Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for award for Ph.D. Degree), Regulations 2009, or the University Grants Commission.

Provided further that the award of degrees to candidates registered for the M.Phil/Ph.D. programme prior to July 1, 2009, shall be governed by the provisions of the then existing Ordinances/By laws/Regulations of the Institution awarding the degrees. All such Ph.D. candidates shall be exempted from the requirement of the minimum eligibility conditions of NET/SELT/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities./colleges/Institutions subject to the fulfillment of the following conditions:

- a) Ph.D. Degree of the candidate awarded in regular mode only.
 - b) Evaluation of the Ph.D thesis by at least two external examiners.
 - c) An open Ph.D. viva-voce of the candidate has been conducted.
 - d) The Candidate had published two research papers out of which at least one in referred journal from out of his/her Ph.D. work.
 - e) The candidate had presented two papers in seminars/conferences from out of his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/CSSR/CSIR/ or any similar agency. The fulfillments of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.
- III The clearing of NET Shall not be required for the candidates in such discipline for which NET has not been conducted.
- IV A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.
- A relaxation of 5% shall be allowed at the Bachelor's as well as at Master's Level for the candidates belonging to SC/ST/OBC(non-creamy layers)/PwBD in the category of (a) Visual Impairment (VI) including blindness and low vision and (b) Locomotor Disability (LD) including leprosy cured, dwarfism, acid attack victims and muscular dystrophy. The eligibility of 55% marks (or an equivalent grade, in a point scale wherever the grading system is followed), wherever specified and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace marks procedure.
- V The number of candidates to be called for interview for the DPE post in the colleges, shall be determined in accordance with the guidelines laid down by the University of Delhi.
- VI A relaxation of 5% may be provided (from 55% to 50% of the marks) to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.

- VII A relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by a recognized university, at the master's level shall also be considered eligible.
- VIII The time taken by candidates to acquired M.Phil /Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing research degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experienced for the purpose of direct recruitment/promotion.
- IX NO person shall be appointed to the post of Assistant Professor or equivalent grade in the college, if such persons does not fulfill the requirements as to the qualifications for the appropriate post laid out herein and in the Ordinance XXIV of the Ordinance of the University.
- X For those entering the service in the College, other stipulations prescribed by the UGC/University shall be mandatory for all posts.

Scheme of Examination to shortlist the candidates for direct recruitment of Director Physical Education in Colleges as per Ref. No. Estab.IV/UGC/ Regulation 2018/2023/103 dated 14.02.2023.

Note:

1. The question paper would be bilingual (English and Hindi) and the applicants will have the option to respond in either of the languages. However, the same medium of language must be used throughout.
2. All the questions shall be compulsory. Each question carries 04 marks. There shall be negative marking of 01 mark for each wrong answer. The cutoff for qualifying the written test will be 50% marks of the average score of the top 05% of the candidates. There will be a relaxation of 05% marks for candidates belonging to SC, ST and 10% for PwBD category.
3. If the number of candidates qualifying the written test is more, then a minimum of 30 candidates for the first vacancy and 15 candidates for every additional vacancy, in each category, shall be called for interview in order for their ranks in the merit list prepared on the basis of result of the written test.
4. The marks awarded to the candidates in the written test shall not have any weightage/credit or merit during assessment/interview of the candidates by the Selection Committee as these marks shall be used only for screening/shortlisting purposes.

GENERAL NOTE:

1. The eligible and interested applicants are required to apply online only. The link for submission of application is..... on the college website
Candidates may keep a copy of his/her form for future reference.
2. Application fee should be submitted through online mode as per link given in the advertisement.
Fee once paid shall not be refunded under any circumstances.
3. The qualifications and service conditions shall be such as prescribed by the University of Delhi/UGC from time to time.

4. In accordance with the orders issued by the Central Government and adopted by the University, the upper age limit prescribed for the direct recruitment shall be relaxable in case of candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes (Central List) Persons with benchmark disability, Ex.Service-man and other specified categories.
5. Applicable age relaxation for eligible categories shall be as per guidelines of the University of Delhi/UGC, issued from time to time.
6. The upper age limit shall be determined as per the last date of submission for application.
7. It is the responsibility of the candidate to assess his/her own eligibility for the post in accordance with the advertisement. If the candidate is found to be ineligible as per the prescribed qualification, experience etc., at any stage in the future - during the process of selection or even after appointment, his/her candidature/appointment shall be liable to be cancelled/terminated as per rules.
8. Candidates belonging to SC/ST/OBC/EWS and PwBD categories should mention their category specifically in their applications attach certificate of proof issued by the competent authority.
9. All future correspondence regarding the date of Selection Committee meeting shall be uploaded on the college and DU websites only or/and sent to the email ID provided by the candidates. Candidates must ensure that the email ID provided by them is correct and should check their email (including spam) & college & DU websites on a regular basis. The college would not be responsible for any delay or gap in communication of the information due to technical reasons.
10. Application received with incomplete information or without requisite fee shall be rejected.
11. The college shall verify the antecedents or documents submitted by a candidate at the time of appointment or during the tenure of the service. In case the documents submitted by the candidates are false or the candidate has suppressed relevant information, then his/her services shall be terminated without prejudice to any other action initiated by the college.
12. In case of any advertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the college reserves the right to modify/cancel/withdraw any communication made to the candidates.
13. The college reserves the right not to fill up the post advertised, if the circumstances so warrant.
