Schedule of the computer skill test (35 marks):

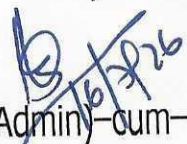
LEVEL	Description	Duration	Date
LEVEL: I (20 marks)	Assessment of Typing speed and accuracy in word processing with the help of Typing Application Software in general desktop computers without any assistive devices/gadgets/special devices.	5 minutes.	08-08-2026 (Saturday)
LEVEL: II (15 marks)	Written Test for Assessment of Proficiency in word processor and spread sheet.	30 minutes.	09-08-2026 (Sunday)
<i>Compensatory time of additional 20 minutes along with prescribed time of 30 minutes only for LEVEL: II of the computer skill test will be given to PwBD candidates.</i>			

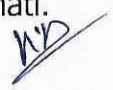
Place of computer skill test will be Guwahati.

Specific venue and reporting time of the Computer Skill Test will be mentioned in the admit cards. Admit Cards may be downloaded from the official website of Gauhati High Court (www.ghconline.gov.in) *w.e.f.* from 3:00 PM of 01-08-2026 till the date of Examination. The candidates shall bring their Admit Cards to the examination hall for appearing in the Main Written Examination.

It may be noted that candidature of candidates is still under scrutiny. The Gauhati High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility condition at any stage.
