**Subject: Constable (Executive) Male and Female in Delhi Police Examination, 2025–
Declaration of result of Computer Based Examination for shortlisting candidates to appear
in Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV).**

The Staff Selection Commission conducted the Computer Based Examination for recruitment of Constable (Executive) Male and Female in Delhi Police Examination, 2025 from 18.12.2025 to 06.01.2026 at various centres across the country.

2. The Computer Based Examination was conducted in multiple shifts; hence, marks scored by candidates have been normalized as per the formula published by the Commission vide Notice dated 02.06.2025. As per the provisions under Para 12.2 of the Examination Notice, normalized marks of the candidates have been used for processing the result to shortlist the candidates for the next stage of Examination [Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)].

3. As per Para 16.5 of the Notice of Examination, minimum qualifying marks in Computer Based Examination (without adding NCC bonus marks) are as follows:

- i) Unreserved: 35
- ii) SC/ ST/ OBC/ EWS: 30
- iii) ESM: 25

4. Based on the cut-off fixed by the Commission in CBE, the number of candidates qualifying for appearing in PE&MT/ DV is as follows:

The Final Answer Keys have been used for processing the results of CBE. The Final Answer Keys, along with Question Papers cum Response Sheets of CBE, as well as marks of the qualified/non-qualified candidates, will be uploaded on the website of the Commission in due course.
